This filing introduces two temporary discount programs for Asymmetric and Symmetric Digital Subscriber Line (A/SDSL) Voice-Data Access Service in Section 17.4.9 (E), Promotional Offerings for Qualifying Students. The proposed revisions allow companies to offer a temporary discount on new A/SDSL service or an upgrade at no additional charge on existing A/SDSL service for customer or subscriber households with a student in grades K through 12 or a technical high school equivalent program who is categorically eligible for a reduced cost or free lunch through the National School Lunch Program.

This promotional offering is intended to benefit low income households with a qualifying student for the purposes of remote schooling due to the national emergency. The projected revenue impact to the special access pool for the remainder of the current test period is de minimis.

In compliance with Section 61.14 of the Commission's Rules, the transmittal, associated files, required Form 159 and \$960.00 filing fee are being transmitted electronically today via ETFS.

(E) Promotional Offerings for Qualifying Students

Existing ADSL Voice-Data Access Service customers can be upgraded to the next highest asymmetric speed level not to exceed 50/100 Mbps. Existing SDSL Voice-Data Access Service customers can be upgraded to the next highest symmetric speed level not to exceed 100/100 Mbps.

1. Introduction

This filing introduces promotional offerings that include two new temporary discount programs for the Asymmetric Digital Subscriber Line (ADSL) and Symmetric Digital Subscriber Line (SDSL) Voice-Data Access Service options. The new temporary discount programs will assist qualifying low-income students in:

- Upgrading an existing ADSL and SDSL Voice-Data Access Service speed
- Subscribing to a new ADSL and SDSL Voice-Data Access Service

The new temporary discount programs are being introduced to recognize the needs of students in low-income households for broadband services during the Covid-19 pandemic. The discount programs will facilitate prolonged at-home student learning by helping existing low-income subscriber households to access much needed higher bandwidths and new low-income subscriber households without broadband access to acquire it.

2. Proposed Tariff Provisions

This filing introduces promotional offerings that include two new temporary ADSL and SDSL Voice-Data Access Service discount programs. Both programs will be offered to wholesale customers (e.g. Internet Service Providers) and ILEC subscribers if the ILEC offers a retail service. The effective period of the programs is from the scheduled filing effective date of October 1, 2020 until June 30, 2021. To be eligible for either program, low-income household subscribers must have a student(s) in grades K-12 or a technical high school equivalent program and qualify for either a reduced cost or free lunch from the National School Lunch Program. The Telephone Company must verify the customer or the customer's subscriber household contains a qualifying student by obtaining documentation regarding reduced cost or free lunch eligibility.

Prior to the end of the promotional period of June 30, 2021, the Telephone Company will provide reasonable notification to the customer of the option to continue the upgraded or new ADSL/SDSL Voice-Data service beyond the promotional period. If the customer does not elect to continue the upgraded or new ADSL or SDSL Voice-Data service, then the Telephone Company will revert the upgraded service back to the original ADSL or SDSL Voice-Data speed in service prior to the promotion or discontinue the new ADSL or SDSL Voice-Data service ordered under this promotion.

The discount programs do not apply to speeds lower than 1 Mbps downstream, nor for speeds higher than 100 Mbps downstream. The Access Order Charge and non-recurring installation charge are waived for both of these discount programs. No minimum service periods or term commitment penalties apply.

2.1 Upgrade on existing ADSL and SDSL Voice-Data Access Service

This filing introduces a temporary upgrade of one speed level, except in the case of current ADSL Voice-Data Access Service 1/6 Mbps subscribers where the upgrade is two speed levels, from the subscriber's current speed level in effect as of September 15, 2020 for customers or a customer's subscriber household with a qualifying student.

Existing ADSL Voice-Data Access Service customers or a customer's subscriber household can be upgraded to the next highest asymmetric speed level not to exceed 50/100 Mbps. Existing SDSL Voice-Data Access Service customers or a customer's subscriber household can be upgraded to the next highest symmetric speed level not to exceed 100/100 Mbps.

Upgrades to speed levels are limited to the following:

2.2 Discount on new ADSL and SDSL Voice-Data Access Service

This filing introduces a temporary 25 percent discount on new ADSL and SDSL Voice-Data Access Service for customers or a customer's subscriber household with a qualifying student. This offering is for new subscribers only. Customers or a customer's subscriber household must not have had service in the past three months prior to the effective date of this offering.

The temporary discount is limited to the following speeds:

New subscribers under this promotion are not eligible for a promotional upgrade to their ADSL or SDSL Voice-Data Access Service once they have subscribed to this offering. The DSL Volume Pricing Plan (VPP) discount applies to this offering. ADSL and SDSL lines in-service under this promotion may be counted toward the DSL VPP monthly commitment level. For customers that meet their monthly DSL VPP commitment level, the DSL VPP discount is applied after the temporary 25 percent discount is applied.

3. Revenue, Cost and Demand Support

NECA used previous Rate Development Task Group (RDTG)¹ surveys to estimate the monthly incremental unit costs for possible migrations to all upgrade speed options from existing voice-data speed options.

In developing estimates of DSL lines that would be eligible for the two promotions, NECA used the percentage of households with children and the percentage of students eligible for a free or reduced-price lunch, which are published by the U.S. Department of Education-National Center For Education Statistics.² For the ADSL/SDSL Voice-Data upgrade promotion, which is available to current subscribers using the speeds listed above, NECA estimated about 17,500 voice-data lines would be eligible. There would be no revenue impact because the promotion only affects the broadband speed available to the subscriber. As subscribers move to a higher speed level, NECA expects additional transport costs would be reported to the traffic sensitive pool. As documented in the 2020 Annual Filing, the transport cost is approximately \$.009 per Mbps per DSL

¹ The Rate Development Task Group (RDTG) is a group of selected participants in the NECA Traffic Sensitive (TS) and Common Line (CL) Pools. Other companies may participate as associates to the RDTG on an ad hoc basis. NECA uses the RDTG to develop cost characteristics representative of pooling companies and to facilitate the rate development process and provide supporting information for NECA tariff filings.

subscriber.³ NECA expects less than \$40,000 of additional unit costs to be reported for the ninemonth period of the promotion, a *de minimis* amount.

For the 25 percent discount promotion, NECA used the following approach. Based on NECA's latest data collections for the Common Line and USF Loops⁴, NECA estimated that there are currently about 56,000 residential lines without broadband service in the study areas of NECA's DSL tariff participants. NECA narrowed it down to about 9,200 voice-data lines meeting the criteria for the low-income population described above. NECA expects that the proposed promotion with a 25 percent discount could help up to 4,600 households (or 50 percent of those low-income households) subscribe to a broadband service for their children.

NECA used the 2020 Annual Filing data to estimate the monthly incremental costs for a new low-income household subscriber. NECA used average revenue requirement projection per voice-data line as an incremental cost incurred by the pool to support each new voice-data subscriber line with a 25 percent promotion discount. NECA estimated an average of \$28.04 incremental cost per line to support each voice-data subscriber line for new low-income households.

For new voice-data lines for low-income households, NECA assumed that most new subscriber lines will use the ADSL 3/25 Mbps speed option. With a 25 percent promotion discount, NECA estimated the member companies would bill an average of \$19.24 per line under the three-year term plan with a 10 percent volume discount.

NECA estimated \$8.81 as the net revenue loss (or \$19.24 - \$28.04) for each low-income household. Assuming the 50 percent subscription rate mentioned above, this amounts to a net revenue loss of \$364,000 for the remaining nine months of the test period. NECA estimated this net revenue loss as -0.4% of total DSL voice-data revenue or -0.2% of total special access revenue projections for the remaining months of the test period. Overall, NECA estimated the pool impact by the proposed discount promotion for low-income households would be *de minimis*.
