This filing revises Sections 7.4 (Public Packet Data Network) and 7.5 (Other Services - Greater than DS3) to remove non-*ex ante* rate elements for Business Data Services packet-based and time division multiplexing greater than DS3 access services for Western Iowa Telephone Association (SAC 351334), based on the company’s detariffing notice filed with the Commission on December 2, 2019 as permitted by the *RoR BDS Order*<sup>1</sup>. This filing also makes a miscellaneous change to the issuing carrier section.
